- Tournament Details: Recurve and Compound Archers will compete on vertical 3-spot 60cm faces for the FITA25 & vertical 3-spot 40cm faces for the FITA18.
Longbow and VI Archers will compete on single-spot 60cm faces on the FITA25 & single-spot 40cm faces on the FITA18 unless otherwise requested.
Equipment Inspection will be at the Judges' pleasure.
There will be up to 4 archers per boss, shooting double detail.
GNAS cards will be requested and must be shown.
Since this is a World Record Status event, **FITA Target Awards** are available for archers scoring over 500 points for either the FITA25 or FITA18 (archers shooting the 3-spot faces only).
As entry is limited, early booking is advised to be sure of a space.
Compound archers will be shooting on bosses with H-frame stands.
GNAS dress regulations will apply.
- Practice: There will be 2 ends of practice to commence at 9:30am.
- Entry Fee: £13 for the Combined FITA, £8 for either single FITA. Preference given to archers entering the Combined FITA. Cheques to be made payable to 'Whitburn Archers'.
- Closing Date: Sunday 24th January 2010. Late entries accepted dependant on space.
